A. Explanatory Notes Pursuant to Malaysian Financial Reporting Standard ("MFRS") No. 134

A1. BASIS OF PREPARATION

The interim financial report is unaudited and has been prepared in accordance with the requirements of Chapter 9, Continuing Disclosure, Paragraph 9.22 of the Main Market Listing Requirements ("LR") of Bursa Malaysia Securities Berhad ("Bursa Securities") and in compliance with Malaysian Financial Reporting Standards ("MFRSs") 134, Interim Financial Reporting issued by Malaysian Accounting Standards Board (MASB), and should be read in conjunction with the Group's annual audited financial statements for the year ended 31 December 2011.

The Group recorded loss before taxation ("LBT") of RM1.77 million in the quarter under review ("Q3 2012") as compared to PBT of RM0.83 million in the preceding year corresponding quarter ("Q3 2011").

The main reasons for the loss in current quarter are as follows:

- 1) Malaysia and Singapore segment recorded a lower revenue of RM46.96 million and LBT of RM2.09 million for current quarter ended 30 September 2012 ("Q3 2012") as compared to revenue of RM56.73 million and Profit before taxation ("PBT") of RM0.36 million for Q3 2011. As such, the results turned from profit to loss were mainly due to decrease in sales to its HDD customers which recorded a decrease by around 20.8% or RM9.77 million as compared to the preceding year corresponding quarter; and
- 2) The Hong Kong and China segment recorded a lower revenue of RM7.92 million and LBT RM75,000 for Q3 2012 as compared to revenue of RM9.90 million and PBT of RM0.22 million for Q3 2011.

B2. COMPARISON WITH PRECEDING QUARTER'S RESULTS

The Group recorded revenue of RM28.86 million in the current quarter ("Q3 2012") as compared to RM34.11 million in the previous quarter ("Q2 2012"), a decrease of RM5.25 million or 15.4%. The Group also recorded a loss before taxation ("LBT") of RM1.77 million for the quarter under review, as compared to previous quarter ("Q2 2012") PBT of RM1.35 million.

The main reasons for the loss in the current quarter as compare to the preceding quarter are as follows:

- 1) Decrease in HDD sales;
- 2) Increase in loss in foreign exchange; and
- 3) Increase in administrative cost due to additional foreign staff costs incurred.

B3. COMMENTARY ON PROSPECTS

The HDD sector would continue to be flat in the coming quarter. However, the Group expects growth from Non-HDD sectors such as Sensor and Control and Medical Devices which may contribute positively to the Group's result at large.
